Early in my career, I learned the benefits consulting industry from Actuaries and Group Benefit Consultants. In 1990, I established my own business providing specialized, custom software for payroll, human resources, and employee benefits.

Over the years, I have developed software for leading oil and gas companies, telecommunications, supply management companies, mining, pulp & paper, healthcare, universities, construction industry. My responsibilities included all aspects of the development projects including gathering and analyzing data requirements, identifying, and analyzing data integration points, developing the database design, implementing, and converting existing data, designing the software, and coding it, testing, training the users and supporting the implementation of the application.

I work with client management, payroll staff, human resources staff, IT staff, and project manager to develop the software they require.
